

## **Town of Grant**

### **RESOLUTION NO. 2021-2**

#### **Adopting Ward Plan and Combining Municipal Wards for Voting Purposes**

WHEREAS, Wisconsin Statutes, Section 5.15, requires all cities, villages, and towns with a population of 1,000 or more to establish municipal wards based on the results of the 2020 Census; and

WHEREAS, Wisconsin Statutes require that each municipality designate the various wards to be created within the municipality by consecutive whole number, geographical description, and population.

NOW, THEREFORE BE IT RESOLVED, that the Town of Grant adopts the wards described as follows:

**Ward 1:** That part of the Town of Grant, lying southerly of a line more fully described as follows: Beginning at the intersection of the corner of the west line of the Town of Grant Town Limit and the east line of the Town of Otter Creek Town Limits on 970 th Ave, Thence easterly along said Town Limits to the Red Cedar River, Thence northerly along the Red Cedar River to County Road MW, Thence easterly along said County Road MW to the intersection of County Road M, Thence northerly along County Road M to 1130 th Avenue, Thence easterly along 1130th Ave. the east line of the Town of Grant, Thence northerly along the east line of the Town of Grant until the northern line of the Town of Grant Town limits along 1210 th Ave., Thence westerly along 1210 th Ave. along the northern line of the Town of Grant Town Limit to the western line of the Town of Grant Town limit and the eastern line of the Town of Otter Creek Town Limit, Thence southerly along the western line of the Town or Grant to 970 th Ave., being the point of ending of this description.

**(Part of County Supervisory District 1)**

**Ward 2** That part of the Town of Grant, lying southerly of a line more fully described as follows: Beginning at the intersection of the southern line of the Town of Grant with the Red Cedar River and the north line of the Town of Colfax Town Limits, Thence easterly along said Town Limits to the eastern line of the Town of Grant Town Limits, Thence northerly along the eastern Town of Grant Town limits to 1130 th Ave, Thence westerly along said 1130 th Ave to County Road M, Thence southerly along County Road M to County Road MW, Thence westerly along County Road MW to the Red Cedar River, Thence southerly along the Red Cedar River to the south line of the Town of Grant, being the point of ending of this description.

**(Part of County Supervisory District 5)**

BE IT FURTHER RESOLVED that Wards 1 and 2 created herein are hereby combined for voting purposes so as to share the common polling place, and such combined wards shall use common ballot boxes and ballots and maintain common election returns for the combined wards at any election for which all officers or referendum questions to be voted on are the same.

BE IT FURTHER RESOLVED that separate returns shall continue to be maintained for the combined wards at any election except where separate ballots are required under Section 5.62 and 5.64 of the Wisconsin Statutes.

Upon passage, a copy of this Resolution shall be filed with the Town Clerk, who shall transmit a copy of the ward plan and this Resolution to the County Clerk within five days of its adoption. This Resolution shall remain in effect for each election until modified or rescinded, in accordance with Statute, or until a new division is made following the next Federal decennial census.
